### **Personal Data Registry**

The personal data collected by Gender Equality Conference 2021, through the forms extended on its pages, will be entered in an automated file under the responsibility of the Data Controller, and duly declared and registered in the General Register of the Data Protection Agency that can be consulted on the website of the Spanish Data Protection Agency (<http://www.agpd.es>), in order to facilitate, expedite and fulfill the commitments established between Gender Equality Conference 2021 and the User or the maintenance of the relationship established in the forms that it fills out, or to respond to a request or consultation of the same.

## **1. COOKIES POLICY**

Access to this Website may involve the use of cookies.
